The hospital is a 1,030-bedded tertiary care centre featuring 11 major and 7 minor operation theatres, 30 emergency beds, and 65 ICU beds, including NICU, PICU, SICU, and ICCU. Its clinical infrastructure is supported by state-of-the-art laboratories, a fully functional blood bank, advanced radiology services including X-ray, ultrasound, CT, and MRI, physiotherapy and audiometry facilities, and a comprehensive pharmacy. Additional patient-centric amenities include private rooms, master health checkup packages, and round-the-clock emergency care.

## ADMISSIONS FRAMEWORK

Our admission process for the **MD/MS (2025-26)** academic year strictly adheres to the guidelines issued by the **Honorable Supreme Court of India**, the **National Medical Commission (NMC)**, and the **Directorate General of Health Services (DGHS)**, MOFHW, New Delhi.

### Eligibility Criteria for MD/MS Admission (Indian Nationals)

Candidates allotted a seat through the centralized counselling by the MCC of DGHS, New Delhi, must meet the following:

Candidates allotted a seat through the centralized counselling by the MCC of DGHS, New Delhi, must meet the following:

- **Qualification:** Passed MBBS with a minimum of **50% marks**.
- **Registration:** Possess a permanent or provisional MBBS registration certificate from the NMC/erstwhile MCI or State Medical Council.
- **Internship:** Completed or likely to complete one year of internship on or before **July 31, 2025**.
- **Entrance:** Qualified in **NEET-PG 2025** (conducted by NBE).
- **Allotment:** Must possess the Provisional Allotment Letter from DGHS/mcc.nic.in.

### Eligibility Criteria for Foreign Medical Graduates

This includes Indian citizens or OCIs with primary medical qualifications from outside India:

- **Screening Test:** Must have qualified the Foreign Medical Graduate Examination (**Screening Test**) (FMGE) as per Screening Test Regulations, 2002.
- **Registration & Internship:** Registered with the NMC/State Medical Council and completed (or likely to complete) their internship on or before **July 31, 2025**.
- **Entrance:** Qualified in **NEET-PG 2025** (conducted by NBE).
- **Allotment:** Must possess the Provisional Allotment Letter from DGHS/mcc.nic.in.

## GENERAL INFORMATION

- Admissions to VELS Medical College and Hospital, are subject to meeting all eligibility criteria set forth by the University and statutory bodies such as the National Medical Commission/Medical Council of India. Any submission of false information or forged documents will result in immediate cancellation of admission, which is irrevocable.

## ELIGIBILITY AND ADMISSION PROCESS

- Appearance in NEET-PG 2025 does not confer any automatic rights to secure a Post graduate MD/MS/Post Graduate Diploma Seat.
- Selection is based on meeting eligibility criteria, medical fitness, and other conditions as prescribed by the MCC of DGHS, National Medical Commission, and the University.
- Candidates with provisional allotment obtained from MCC of DGHS must submit all required original documents and pay tuition fees promptly to avoid delays in the admission process.
- Candidates should ensure that their MBBS degree is recognized as per provisions of the NMC Act, 2019 and the Post Graduate Medical Education Regulations, 2023. If it is found at any time that MBBS degree is not recognized, the candidature / result of the candidate shall be cancelled/ deemed to be cancelled.

## REPORTING AND DOCUMENTATION

- Candidates must report in person at the specified date and time with all original certificates/documents.
- Failure to report or pay fees will result in the inability to proceed on the day of admission.
- Candidates who have deposited their original documents elsewhere must retrieve them, provisional certificates are not accepted.

## UNIVERSITY REGULATIONS

- Admitted students are subject to the University's rules regarding syllabus, examinations, fees, discipline, and fee refund policies.
- The University reserves the right to amend regulations in accordance with statutory council guidelines.
- Tuition and other fees for subsequent academic years must be paid by the due date, or enrolment may be terminated.

## ATTENDANCE AND LEAVE POLICY

- Number of working days will be as per NMC norms.
- Students are advised against taking extended leaves during the course of study and should complete their course in three years as per NMC norms.
- Leave due to illness or maternity will extend the study period by the same number of days for which maternity/paternal leave and total excess casual leave taken have been availed in 3 years.
- Re-admission after a study break requires a condonation order from the University and payment of the prescribed fees, in addition to obtaining approval from the NMC, whichever applicable.

## TRAINING REQUIREMENTS

- Students must serve as full-time residents and attend at least 80% of training to be eligible for examinations.
- Rigorous training and class attendance are essential for acquiring comprehensive medical knowledge.

## POSTGRADUATE ACADEMIC AND TRAINING REQUIREMENTS

**To be eligible for the final examinations, postgraduate students must complete the following requirements:**

- One poster presentation
- One paper presentation
- Research papers published one per year; one published as first author; one in Scopus and other two in Scopus or Web of Science or Pubmed indexed journals.

## MANDATORY COURSES

- **Research Methodology:** Complete an online course in the first year, with certification required for final exam eligibility.
- **Ethics:** Complete a course in ethics, including Good Clinical Practices and Good Laboratory Practices, in the first year, with certification necessary for exam participation.
- **Cardiac Life Support Skills:** Complete Basic and Advanced Cardiac Life Support courses in the first year, with certification mandatory for exam eligibility.
- These requirements are applicable to all postgraduate students and are integral to the eligibility criteria for final examinations and any other amendments notified by the statutory body from time to time.

## DISTRICT RESIDENCY PROGRAMME

- To integrate Postgraduate students into the healthcare services, participation in the District Residency Programme is mandatory for a period of 3 months, providing essential exposure to the District Health System and District Hospitals.

## NO MIGRATION


- No student admitted in PG courses shall be permitted migration to any other Medical institutions as per NMC Norms.

## TAMIL NADU MEDICAL COUNCIL DIRECTIVES

- **Other state Candidates pursuing postgraduate, should compulsorily register in Tamil Nadu Medical Council “within three months of admission”**
- In case of failure to register within the prescribed time (3 Months) Rs.10,000/- would be levied as fine, in addition to the normal registration fees.

## RAGGING IN ANY FORM IS PROHIBITED IN THE COLLEGE CAMPUS
